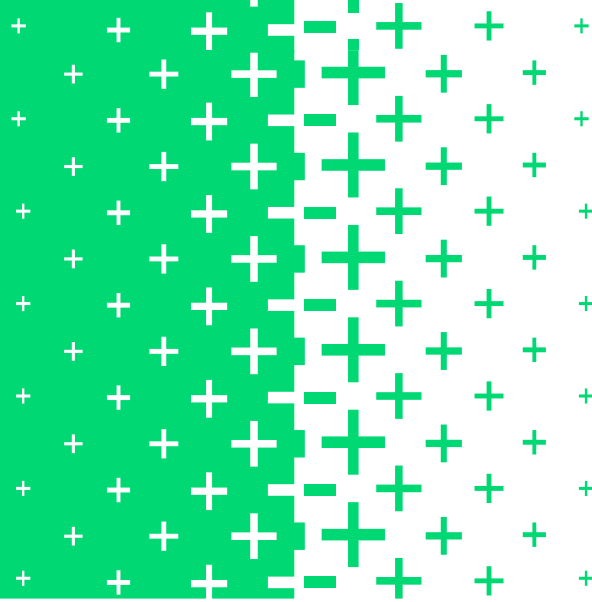


# MI Activation with a Loan Close Date



## How to Activate Coverage with Enact

1. Locate your **Commitment/Certificate Number**.
2. Enter the **Loan Close Date** on the Mortgage Insurance Activation Instructions form that accompanied the Commitment/Certificate.
3. How to Submit:

Enter the **Loan Close Date** and remit payment via check directly to Enact at address provided on form.

OR

Enter the **Loan Close Date** and remit payment via Wire/ACH by emailing the completed form to [CertInfo@EnactMI.com](mailto:CertInfo@EnactMI.com) and follow Wire/ACH instructions provided on form. Remember to include your Enact Master Policy number.
